O: What is white collar crime?

A: Because of their non-violent nature, the general public does not tend to think of white-collar crimes as being particularly serious. However, the state and federal governments do not share this view. Identity fraud, extortion, forgery and mail fraud are some of the state white collar offenses individuals are frequently charged with. State punishments for white collar criminal convictions depend on the jurisdiction in which they are convicted. Federal offenders are punished in accordance with the federal sentencing guidelines. For instance, someone who is found guilty of mail fraud may be fined up to \$1 million and sentenced to as long as 30 years in prison.

Pie dough (can be store bought or homemade)

¾ cup granulated sugar

½ cup cornstarch

2 teaspoons grated lemon zest

1/8 teaspoon ground allspice

1/8 teaspoon ground cinnamon

1/8 teaspoon kosher salt

6 cups blueberries (about 2 pounds)

1 tablespoon of butter, cut into small squares

1 egg yolk

1 tablespoon of heavy cream

1 tablespoon of course sugar, for garnish



April 28th is National Blueberry Pie Day. Celebrate by making this sweet treat!

- 1. Preheat oven to 400 degrees. Roll out half of the pie dough to fit an 8- or 9-inch pie dish. To prevent the dough from sticking and to ensure uniform thickness, roll from the center of the dough outwards and keep lifting up and turning the dough a quarter turn as you roll. Refrigerate while you make the pie filling.
- 2. Stir sugar, cornstarch, lemon peel, allspice, cinnamon and salt in a large bowl. Add blueberries and gently toss to combine. Transfer the blueberry filling to the prepared pie crust. Refrigerate while you prepare the lattice crust.
- 3. Roll out the second half of dough to a similar size as before. Cut into 3/4-inch strips. Lay five strips over filled pie, parallel and equally spaced from one another. Fold back first, third and fifth strips then lay another strip of dough perpendicular. Repeat until the pie has been covered with a lattice crust.
- 4. Make egg wash by whisking egg yolk and heavy cream together and brush over pie dough. Sprinkle tablespoon of coarse sugar over crust. Refrigerate for 20 minutes before baking.
- 5. Bake chilled pie on baking sheet for 20 minutes, reduce heat to 350 degrees then continue baking for 35-45 minutes, or until crust is golden. Cool completely before cutting.
